ORDINANCE NO. 2011-02

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ST. CLOUD, FLORIDA, AMENDING ORDINANCE 2003-65, AN ORDINANCE WHICH ASSIGNED A ZONING DESIGNATION OF PLANNED UNIT DEVELOPMENT (PUD) TO EAST ST. CLOUD **COMMERCE CENTER LOCATED IN SECTION 12, TOWNSHIP 26 SOUTH, RANGE** EAST; PROVIDING FOR FILING OF THE **PLANNING** 30 BOARD RECOMMENDATION PROOF OF **PUBLICATION,** AND SEVERABILITY, **CONFLICTS AND EFFECTIVE DATE.**

WHEREAS, on December 11, 2003, the City Council lawfully adopted Ordinance 2003-65, an ordinance which rezoned the subject property to Planned Unit Development (PUD) and assigned zoning regulations for the subject property; and,

WHEREAS, the City Council has received the Planning Board's recommendation after its review of the proposed rezoning at its meeting of January 18, 2011, and said Board has recommended approval of the amendment; and,

WHEREAS, the City Council has held a Public Hearing on this matter after directing the City Clerk to provide public notice thereof and such public notice has been provided, as required by law; and,

WHEREAS, it is in the best interest of the City of St. Cloud and the citizens thereof that the proposed amendment be approved.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Cloud, Florida, as follows:

SECTION 1:

The zoning standards and regulations contained herein shall apply to the development known as East St. Cloud Commerce Center, located within the City Limits of the City of St. Cloud, Florida in Section 12, Township 26 South, Range 30 East, further described as:

East St. Cloud Commerce Center, according to the Official Plat thereof, as recorded in Plat Book 17, Pages 118 and 119 of the Public Records of Osceola County, Florida.

SECTION 2:

The amendments to the East St. Cloud Commerce Center are presented below. The following list of uses will supersede the list of permitted uses as identified in Ordinance 2003-65.

Ordinance No. 2011-02 East St. Cloud Commerce Center DRC Case #10-95.07 Permitted Uses: **Answering Service** Antique Shop Appliances, Sales and Service Artist and Photographic Studios Bakeries, Most goods sold on premises at retail (Not wholesale) **Banks and Financial Institutions Barbershops and Beauty Shops** Bicycle, Sales and Service **Bioanalytical Labs** Bondsman Book, Stationary and Newsstands Catering only (No restaurant facilities) City and County Government Office and Facilities **Civic Clubs** Contractor (Business office only) **Dance and Music Studies Data Processing Center Dive Shop Employment Agency** Florist and Gift Shop Food Specialty Store, including Confectionery, Ice Cream, Delicatessen, Fruits, Vegetables, Candy, Nuts, Coffee, Meat, Tea, Convenience Food and Groceries when such establishment does not exceed 3000 sq ft gross floor area **Funeral Homes Furniture Sales Government Offices** Gymnastic/Health Spa Facility Hardware Hobby and Craft Shop Interior Decorating and Window Treatment Laundromats and Dry Cleaning Establishments for general retail trade, on-premises or offpremises cleaning; does not include distribution centers **Medical Office** Office, Business and Professional Pharmacy Places of Worship, with their attendant educational/recreational building, excluding schools Printing and Duplicating, Retail Radio, TV and Electronic Sales and Service Repair Shops, Minor services (i.e., shoes, jewelry, electronics, small appliances) **Tailoring Shops** Video Rental Store Conditional Uses: Adult Daycare Clairvoyant, Fortune Teller Dental/Medical Laboratories

SECTION 3:

Upon adoption of this ordinance, the Planning Board recommendation and "Proof of Publication" of the required Public Hearing notice shall be filed in the City Manager's Office.

SECTION 4:

If any section or portion of a section of this ordinance proves to be invalid, unlawful or unconstitutional, it shall not be held to impair the validity, force or effect of any other section or part of this ordinance.

SECTION 5:

This ordinance shall be published as provided by law and shall take effect immediately upon its second reading and final passage.
