EXHIBIT "A"

Article X, Section 34: <u>Limitations on Leasing</u>; <u>Prohibition Against Time Sharing & Short-Term Rental</u>.

No residence shall be used for short term rental purposes. Nightly or monthly rentals are strictly prohibited. Owners shall be permitted to rent their residence but shall utilize a written and duly executed lease agreement. Owners must receive the written approval of the Association prior to any tenant taking occupancy. The term of any initial lease shall be SIX (6) months, and no more than three (3) times per calendar year. A copy of the executed lease agreement must be provided prior to the Tenant's occupancy in order for the Association to have evidence of record that the minimal term requirement has been met. All intended occupants 18 years of age or older shall be listed on the lease agreement and all vehicles registered to tenants shall be listed by make, model and tag.
